Texas Trophy Wildlife, LLC has the right to refuse any specimen at any point in the process, due to damage acquired in the harvest or storage of the specimen before arriving at our facility. When a specimen arrives frozen it is impossible to assess the condition. Therefore we reserve the right to fully thaw the trophy and carefully observe all aspects of the specimen. We will call you if we find any thing that may become or is a problem. We will explain to you your options. At that point we will only continue at your request with a statement signed by you that you have been notified and explained the damage and you chose to continue the process at your own risk and Texas Trophy Wildlife, LLC and its managing partners will not in any way be responsible or liable.

No work will be started until the non-refundable deposit (if-applicable) is paid, and all forms are complete with all tag and license numbers.

All tag and license numbers will be correct and you will sign here stating you have reported this harvest to the proper wildlife authorities.

Due to storage space, all specimens will be caped, skinned and frozen upon arrival. There will be a storage fee of \$25.00 and a skinning fee depending on the size of the specimen that will apply. If at any time you choose not to mount your trophy you will be responsible for these charges before you may pick your trophy up.

All permits needed and shipping charges will be your responsibility.

No work will be picked up or shipped until paid in full.

You will be notified by phone of the completion of you mount. You will have 30 days from this notification to pick up your finished mount. After thirty days you will receive a certified letter giving you an additional 30 days to pay in full and pick up your mount. If at this time you do not pay in full and pick up your mount it will be sold and your deposit and any other monies you have paid will not be refunded. After your mount has been placed on our for sale list, if you decide to pick it up you will have to pay the sale price.
